According to the Universal Declaration of Human Rights, Article 19, everyone has the right to freedom of opinion and expression; this right includes freedom to hold opinions without interference and to seek, receive and impart information and ideas through any media and regardless of frontiers (UN General Assembly, 1948). While this declaration from the United Nations helps to encourage the sharing of knowledge and ideas among people and cultures from around the world, it doesn't require that people express those ideas with universal respect for differences in culture, race, political views, ideology, religion or really anything else that helps to create our unique identities. In order to truly advance our society and make our world a better place for everyone, we must be able to have honest conversations that come from a place of mutual respect and serve to build up our communities rather than divide and polarize those around us. Freedom of expression by itself will not change the world for the better; however, if coupled with a universal desire to respect one another and approach all situations with a mindset that seeks to share and listen for understanding, we can advance our communities and our world in ways that we could never imagine or think possible.

While the freedom of expression rights may guarantee a person the right to say or think freely without the threat of punishment, it does not guarantee that the person's thoughts or opinions will be accepted and understood by their audience, nor does it guarantee the person's audience will be respectful and open-minded to that certain thought or opinion. To assume that freedom of expression can help build a "better" world just because people are free to think and say as they wish without punishment, is to assume that those receiving that message are either in agreement or open-minded enough to consider another perspective. In today's world, there are many live examples of why freedom of expression alone cannot help us evolve and move in the right direction. The current battles that are so prominent in the news today between the Republican party and the Democratic party are a great example of this. While both sides are able to freely demonstrate and vocalize their thoughts and opinions on certain issues affecting our country, there is rarely a time where everyone agrees with one another or can come together through compromise to create a resolution together. To get more specific, the recent overturning of Roe v. Wade on June 24, 2022 by the U.S Supreme Court - which

By starting with education on respect and character early in our schools, the youth of today can be instilled with values that they will be able to carry with them and share out in their communities throughout their lives.
