in. Before becoming the foundational pieces of the equality movement, MLK was a baptist minister, an ordinary job that didn't offer a voice beyond their community if any. People of Russia were basically not allowed to form an opinion of their own but instead,

had to only agree with their ruler Stalin. For the people of Russia, there was no equality for citizens in their country and there was nothing they could do about it, because they couldn't speak out against unfair and unholy rules. Examples like this in history are why America's democracy is looked on in such a positive manner, the democracy gives American citizens the choice to form their own beliefs and the ability to express their beliefs.
